Swimming Lessons - June 2018

As part of the National Curriculum, **Year 4's** will be having swimming lessons at Regents Park Community College. All sessions will be fully supervised and taught by fully qualified instructors, as well as members of our own teaching staff being present. These sessions will take place on the following dates:

Pupils will be *walking* from Mason Moor to Regents Park at 12.30pm and then return to school by approximately 15:00. As the swimming sessions are during the afternoon we would ask that children do not come to school wearing their swimming costumes underneath their clothes, but get changed at the pool. Please note the following requirements:

- Pupils *may* bring a swimming cap but long hair *must* be tied up.
- Girls must wear a one-piece swimming costume.
- No jewellery is to be worn and all plasters must be removed.
- If your child has a verruca, this must be covered by Bazooka or a swim sock.
- Children suffering from cold sores or open wounds will not be able to swim.
- Children who have inhalers must bring them to school to take with them to the pool.

In order for your child to take part, and for us to plan the swimming sessions effectively, we need to have the attached consent form completed and returned to school as soon as possible.
